CERTIFICATE OF WATER RIGHT

This Is to Certify, That DOROTHY M. BUTLER & MARVIN R. MANES

of Route 1, Box 1985, Bandon, State of OR 97411, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Spring Creek and 0.9 acre-foot of stored water from Winter and Sherertz Reservoir #2, constructed under Permit R-6751 a tributary of Coquille River for the purpose of irrigation of 1.8 acres, supplemental irrigation of 19.0 acres, frost control and harvesting of cranberries of 19.6 acres under Permit No. 42567 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 14, 1971 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.00 cubic foot per second; being 0.045 cfs for irrigation, 0.23 cfs for supplemental irrigation, 1.0 cfs for frost protection, 0.58 cfs for harvesting of cranberries and 0.9 a.f. for frost protection and harvesting of cranberries or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, Section 20, T28S, R14W, WM; 605 feet South and 50 feet East from N 1/4 corner Section 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
