CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DWAYNE C. BUSH

of 90536 Territorial Rd., Junction City, State of OR 97448, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Fern Ridge Reservoir constructed under Permit R-1625

a tributary of Long Tom River for the purpose of irrigation of 146.8 acres

under Permit No. 40280 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 3, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.65 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, as projected within Inman DLC 57, Section 8, T17S, R5W, WM; 120 feet North and 1950 feet East from SW corner, Inman DLC 57.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~of one cubic foot per second per acre,~~ a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of Contract 14-06-100-9049 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Department,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
