CERTIFICATE OF WATER RIGHT

This is to certify, That DELS FARM, INC.

of 11228 Silverfalls, Aumsville, State of OR 97325, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well #4

a tributary of Beaver Creek for the purpose of irrigation of 100.4 acres

under Permit No. G-5870 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 6, 1973 for 0.67 cfs and December 13, 1974 for 0.11 cfs that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.78 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE 1/4 NW 1/4, as projected within W. Simpson 52, Section 20, T8S, R1W, WM; 180 feet South and 1400 feet East from SE corner H. Geer DLC 51.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.3 acres NW 1/4 SE 1/4 as projected within N. Wisdom DLC 70
 - 33.9 acres SW 1/4 SE 1/4 as projected within N. Wisdom DLC 70
- Section 17

- 4.6 acres NE 1/4 NE 1/4 as projected within W. Simpson DLC 52
 - 19.6 acres NW 1/4 NE 1/4 as projected within N. Wisdom DLC 70
 - 6.1 acres NW 1/4 NE 1/4 as projected within W. Simpson DLC 52
 - 12.3 acres NE 1/4 NW 1/4 as projected within W. Simpson DLC 52
 - 22.6 acres SE 1/4 NW 1/4 as projected within W. Simpson DLC 52
- Section 20
Township 8 South, Range 1 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
