## CERTIFICATE OF WATER RIGHT

This is to certify, That L. R. PETE

of 26707 S. Meridian Road, Aurora , State of OR 97002 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed stream and Peters Pond constructed under Permit R-5891

a tributary of Pudding River for the purpose of supplemental irrigation of 37.3 acres. The use allowed herein may be made anytime between October 1 and March 31 that water can be put to beneficial use\* under Permit No. 44141 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 17, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.47 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SW 1/4, Section 18, T4S, R1E, WM; Stream - 1420 feet North and 1150 feet East; Reservoir - 1450 feet North and 1040 feet East both from SW corner Section 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 1.0 acre-feet per acre for each acre irrigated during the period from October 1 to March 31, provided further that the right allowed herein, together with the amount secured under any other right existing for the same land shall not exceed 2.5 acre-feet for each acre irrigated in any one year. The use of water during the period from October 1 to March 31 as authorized herein shall not establish priority of right as against future appropriations\*\* and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.7 acres NW 1/4 SW 1/4
27.6 acres SW 1/4 SW 1/4
Section 18
Township 4 South, Range 1 East, WM

\*by irrigation for immediate crop growth

\*\*of surface water for beneficial uses or for storage for such beneficial uses, other than similar rights for irrigation from October 1 to March 31.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
