CERTIFICATE OF WATER RIGHT

This Is to Certify, That WALTER L. AND MARY B. MCGREW

of 15218 Tye Road, Umpqua, State of OR 97486, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Umpqua River and spring stream

a tributary of Pacific Ocean for the purpose of domestic use for one family and irrigation of 5.5 acres

under Permit No. 37687 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 16, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.055 cubic foot per second, being 0.04 cfs from Umpqua River for irrigation, if available at the old points of diversion, NW 1/4 NE 1/4, SE 1/4 NE 1/4, Section 32, T24S, R7W, WM; 870 feet North and 700 feet East, 290 feet South * or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 2 (SE 1/4 NE 1/4), SW 1/4 NE 1/4, Section 32, T24S, R7W, WM; River - 185 feet South and 340 feet East; Stream - 860 feet South and 1250 feet East, both from the NW corner Lot 2 (SE 1/4 NE 1/4), Section 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

* and 1800 feet East, both from SW corner Lot 1 (NW 1/4 NE 1/4), Section 32, and 0.005 cfs for domestic and 0.01 cfs for irrigation from spring stream

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 45627, Volume 38, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered August 31, 1979, approving transfer application 4255, and is issued to confirm a change in point of diversion approved by the same order and supersedes certificate 45627.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
