and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at page 1; that the priority of the right thereby confirmed dates from 1854

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.90 cubic feet per second

The point of diversion is located in the SW 1/4 SE 1/4, Section 11, T39S, R3W, WM; Davidson Ditch - North 39 degrees 02 minutes East, 1184 feet from S 1/4 corner Section 11.
