CERTIFICATE OF WATER RIGHT

This Is to Certify, *That*

THE POPLARS RANCH

of Star Route, Silver Lake, State of OR 97638, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Poplar's Wells 3 & 4

a tributary of Silver Lake (Fort Rock Basin) for the purpose of irrigation of 160.8 acres

under Permit No. U-690 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 29, 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.21 cubic feet per second from Well 3; 0.80 cfs from Well 4

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the Well 3 - SW 1/4 SW 1/4, Section 34; Well 4 - SW 1/4 NE 1/4, Section 33; T26S, R15E, WM; Well 3 - 80 feet North and 50 feet East from SW corner Section 34; Well 4 - 3950 feet North and 1330 feet West from SE corner Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
