## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** ROBERT K. HANNA

of 4150 SW Helmholtz Way, Redmond, State of OR 97756, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Lonie Well #1

a tributary of Fort Rock Basin for the purpose of irrigation of 36.3 acres

under Permit No. G-2652 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 5, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE 1/4 NW 1/4, Section 12, T26S, R14E, WM; 80 feet South and 90 feet West from N 1/4 corner Section 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20.1 acres NE 1/4 NW 1/4  
16.2 acres SE 1/4 NW 1/4  
Section 12  
Township 26 South, Range 14 East, WM

This certificate is issued to confirm changes in place of use approved by orders of the Water Resources Director entered July 28, 1980 and November 10, 1980, and supersedes certificate of water right recorded at page 35642, Volume 27, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
