## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of Road 513-A, Fort Rock , State of OR 97735 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Mattis Irrigation Well No. 2

a tributary of Fort Rock Basin irrigation of 75.0 acres

for the purpose of

under Permit No. G-6571 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 10, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.94 cubic foot per second

The well is located in the SE 1/4 NW 1/4, Section 31, T26S, R14E, WM; 2600 feet South and 2900 feet West from the NE corner Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
