## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** CHARLES AND BARBARA SCHLECHTER

of 9110 Waconda Road, Salem, State of OR 97305, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Carnes Creek for the purpose of irrigation of 11.65 acres

under Permit No. G-3404 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 16, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.14 cubic foot per second, if available at the old well location - NW 1/4 NW 1/4, as projected within Benet DLC 58, Section 11, T6S, R2W, WM; 80 feet South and 870 feet East from NW corner, Section 11.

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 NW 1/4, as projected within Benet DLC 58, Section 11, T6S, R2W, WM; 150 feet South and 680 feet East from NW corner Section 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in point of appropriation approved by an order of the Water Resources Director entered June 8, 1982, and supersedes certificate of water right recorded at page 38265, Volume 30, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
