CERTIFICATE OF WATER RIGHT

This is to Certify, That DELANEY P. KETCHUM

of The Dalles, State of Oregon has a right to the use of the waters of Five Mile Creek (for Tract #1) and Eight Mile Creek (for Tract #2), tributaries of Fifteen Mile Creek; for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wasco County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 7, at page 406; that the priority of the right thereby confirmed dates from 1878 for Tract #1, and 1875 for Tract #2;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Three acre feet per acre in any irrigation season;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1.

Nineteen and four tenths (19.4) acres in the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ NW $\frac{1}{4}$); Eleven and seven tenths (11.7) acres in the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) and Three and four tenths (3.4) acres in the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Nine (9); Five and three tenths (5.3) acres in the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Four (4), Township One (1) North, Range Fourteen (14) East of the Willamette Meridian, being a total of 29.8 acres.

Tract #2.

Seven tenths (0.7) acre in the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Four (4); One and eight tenths (1.8) acres in the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$); Six and four tenths acres in the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$); One and six tenths (1.6) acres in the Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$ NW $\frac{1}{4}$) and Thirteen and two tenths (13.2) acres in the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Nine (9), Township One (1) North, Range Fourteen (14) East of the Willamette Meridian, being a total of 23.7 acres.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
