CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

DEL RIO ORCHARDS
of 40 N RIVER RD GOLD HILL OR 97525
has a right to the use of the waters of ROGUE RIVER
a tributary of PACIFIC OCEAN for the purpose of
PRIMARY AND SUPPLEMENTAL IRRIGATION.

The right has been perfected under Permit 35271. The date of priority is JUNE 18, 1970. The right is limited to not more than 0.820 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located in the

SW 1/4 SW 1/4, Section 17, T 36 S, R 03 W, WM;
100 FEET NORTH & 1280 FEET EAST FROM SW CORNER, SECTION 17

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
