CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

CLYDE HOLLIDAY
of ROUTE 2, BOX 90 JOHN DAY OR 97845
has a right to the use of the waters of
JOHN DAY RIVER
TRIBUTARY OF COLUMBIA RIVER

for the purpose of IRRIGATION.

The right to the use of these waters has been perfected under Permit 44742. The date of priority is OCTOBER 29, 1979. The right is limited to not more than 0.93 CUBIC FOOT PER SECOND. or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located in the

(point 1) NE 1/4 SW 1/4, Section 14, T 13 S, R 32 E, WM;
2040 FEET NORTH & 2020 FEET EAST FROM SE COR SECTION 15
(point 2) SW 1/4 SE 1/4, Section 15, T 13 S, R 32 E, WM;
970 FEET NORTH & 1910 FEET WEST FROM SE COR SECTION 15

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
