CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

VERNON R MORGAN
of 11657 TOWERS RD SE STAYTON OR 97383
has a right to the use of the waters of
A SLOUGH CHANNEL AND RESERVOIR #2, TRIBUTARY OF NORTH SANTIAM
RIVER, CONSTRUCTED UNDER PERMIT R-8135.

for the purpose of IRRIGATION AND SUPPLEMENTAL IRRIGATION.

The right to the use of these waters has been perfected
under Permit 44873. The date of priority is
JUNE 19, 1979

The right is limited to not more than
0.74 CUBIC FOOT PER SECOND
or its equivalent in case of rotation, measured at the point of
diversion from the source. The point of diversion is located in
the

DLC 47, SE 1/4 SW 1/4, Section 16, T 09 S, R 01 E, WM;
2100 FEET SOUTH & 300 FEET WEST FROM CENTER SECTION 16.

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-EIGHTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 2.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year. The
right shall be limited to any deficiency in the available supply of
any prior right for the same land and shall not exceed the
limitation allowed herein.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
