CERTIFICATE OF WATER RIGHT

This is to Certify, That WM. T. VANDERPOOL

of Dufur, State of Oregon has a right to the use of the waters of Fifteen Mile Creek for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wasco County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 7, at page 406; that the priority of the right thereby confirmed dates from 1860 for Tract #1; 1862 for Tract #2, and 1893 for Tract #3;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Three acre feet per acre in any irrigation season;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1. Nine and nine tenths (9.9) acres in the Northwest Quarter of the Northeast Quarter (NW1/4NE1/4), Twenty-two and fourteen hundredths (22.14) acres in the Southwest Quarter of the Northeast Quarter (SW1/4NE1/4), Two and four tenths (2.4) acres in the Northeast Quarter of the Northwest Quarter (NE1/4NW1/4) and Ten and forty-four hundredths acres in the Southeast Quarter of the Northwest Quarter (SE1/4NW1/4) of Section Thirty-four (34), Township One (1) South, Range Thirteen (13) East of the Willamette Meridian, being a total of 44.88 acres.

Tract #2. Ten and thirty-three hundredths (10.33) acres in the Northwest Quarter of the Northeast Quarter (NW1/4NE1/4) and Eighteen and Fifty-four hundredths (18.54) acres in the Northeast Quarter of the Northwest Quarter (NE1/4NW1/4) of Section Thirty-four (34), Township One (1) South, Range Thirteen (13) East of the Willamette Meridian, being a total of 28.87 acres.

Tract #3. Nine and thirty-six hundredths (9.36) acres in the Southeast Quarter of the Northwest Quarter (SE1/4NW1/4) of Section Thirty-four (34), Township One (1) South, Range Thirteen (13) East of the Willamette Meridian.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
