CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

TOM DE ARMOND  
of 11463 BROADACRES RD NE HUBBARD OR 97032  
has a right to the use of the waters of  
TWO WELLS IN THE PUDDING RIVER BASIN

for the purpose of IRRIGATION

The right to the use of these waters has been perfected under Permit G 7574. The date of priority is JUNE 27, 1977

The right is limited to not more than 2.030 CUBIC FEET PER SECOND; BEING 0.13 CFS FROM OLD WELL FOR IRRIGATION AND 1.9 CFS FROM NEW WELL FOR SUPPLEMENTAL IRRIGATION or its equivalent in case of rotation, measured at the well. The well is located in the

(well # 2)DLC 57, NW 1/4 NW 1/4, Section 33, T 04 S, R 01 W, WM; 770 FEET NORTH & 250 FEET EAST FROM NE CORNER, CHURCHILL DLC 56  
(well # 1)DLC 57, SE 1/4 SE 1/4, Section 29, T 04 S, R 01 W, WM; 1430 FEET NORTH & 1110 FEET WEST FROM NE CORNER, CHURCHILL DLC 56

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
