THIS IS TO CERTIFY, that

PORTLAND, CITY OF, BUREAU OF PARKS
 of 1120 SW 5TH PORTLAND OR 97204
 has a right to the use of the waters of
 UNNAMED DRAINAGEWAY TRIBUTARY OF CRYSTAL SPRINGS CREEK

for the purpose of IRRIGATION.

The right to the use of these waters has been perfected under Permit 30829. The date of priority is AUGUST 26, 1965. The right is limited to not more than 1.64 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located in the

DLC 49, SE 1/4 SW 1/4, Section 13, T 01 S, R 01 E, WM;
 5400 FEET NORTH & 1550 FEET EAST FROM NW CORNER OF G. WILLIS DLC #58
 DLC 49, NW 1/4 NW 1/4, Section 24, T 01 S, R 01 E, WM;
 4500 FEET NORTH & 1370 FEET EAST FROM NW CORNER OF G. WILLIS DLC #58

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
