CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

JACK & BESSIE KALINA
of 3190 SW OAKVILLE RD ALBANY OR 97321
has a right to the use of the waters of
TWO WELLS, IN CALAPOOIA RIVER BASIN

for the purpose of IRRIGATION.

The right to the use of these waters has been perfected
under Permit G 6328. The date of priority is
MARCH 3, 1975.

The right is limited to not more than
0.15 CUBIC FOOT PER SECOND; BEING 0.10 CFS FROM WELL #1 AND 0.05 CFS
FROM WELL #2
or its equivalent in case of rotation, measured at the well. The
well is located as follows:

(well # 1)DLC 83, NW 1/4 SE 1/4, Section 14, T 11 S, R 04 W, WM;
1350 FEET NORTH & 1740 FEET WEST FROM SE CORNER, SECTION 14
(well # 2)DLC 83, NE 1/4 SE 1/4, Section 14, T 11 S, R 04 W, WM;
1340 FEET NORTH & 340 FEET WEST FROM SE CORNER, SECTION 14

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-EIGHTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 2.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
