CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

has a right to the use of the waters of
YACHATS RIVER AND SPRING STREAM, TRIBUTARY OF PACIFIC OCEAN

for the purpose of DOMESTIC USE FOR ONE FAMILY AND
IRRIGATION

The right to the use of these waters has been perfected
under Permit 36129. The date of priority is
APRIL 12, 1971

The right is limited to not more than
0.095 CFS; BEING 0.005 CFS FROM SPRING STREAM FOR DOMESTIC USE &
0.09 CFS FROM YACHATS RIVER FOR IRRIGATION
or its equivalent in case of rotation, measured at the point of
diversion from the source. The point of diversion is located in
the

(point 1) NW 1/4 SE 1/4, Section 1, T 15 S, R 11 W, WM;
2060 FEET NORTH & 3250 FEET EAST FROM SW CORNER, SECTION 1
(point 2) LOT 2, SW 1/4 NE 1/4, Section 1, T 15 S, R 11 W, WM;
2650 FEET NORTH & 2990 FEET EAST FROM SW CORNER, SECTION 1
(point 3) NW 1/4 SE 1/4, Section 1, T 15 S, R 11 W, WM;
2380 FEET NORTH & 2690 FEET EAST FROM SW CORNER, SECTION 1

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-EIGHTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 2.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
