THIS IS TO CERTIFY, that

has a right to the use of the waters of  
AN UNNAMED STREAM AND BURGESS CREEK, A TRIBUTARY OF GRAVE CREEK

for the purpose of IRRIGATION

The right to the use of these waters has been perfected under Permit 39987. The date of priority is APRIL 10, 1975. The right is limited to not more than 0.02 CUBIC FOOT PER SECOND; BEING 0.01 CFS FROM BURGESS CREEK AND 0.01 CFS FROM UNNAMED STREAM or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located in the

- (point 1)                      NE 1/4 SE 1/4, Section 13, T 34 S, R 06 W, WM;  
270 FEET SOUTH & 1280 FEET WEST FROM E1/4 CORNER, SECTION 13.
- (point 2)                      NE 1/4 SE 1/4, Section 13, T 34 S, R 06 W, WM;  
590 FEET SOUTH & 400 FEET WEST FROM E1/4 CORNER, SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
