CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

E M HUNTLEY
C/O RALPH HUNTLEY
of 277 NE SHERMAN STREET SHERIDAN, OR 97378
has a right to the use of the waters of TWO UNNAMED STREAMS AND A
RESERVOIR, CONSTRUCTED UNDER PERMIT R-5262, TRIBUTARY OF DEER CREEK
for the purpose of DOMESTIC USE FOR SIX FAMILIES AT CAMP SITES AND
RECREATION.

The right to the use of these waters has been perfected
under Permit 33283. The date of priority is SEPTEMBER 5, 1968.
The right is limited to not more than 0.02 CUBIC FOOT PER SECOND,
BEING 0.01 CFS FOR DOMESTIC FROM WEST UNNAMED STREAM & 0.01 CFS
FOR RECREATION FROM EAST UNNAMED STREAM & RESERVOIR
or its equivalent in case of rotation, measured at the point of
diversion from the source. The point of diversion is located as
follows:

(point 1) SE 1/4 SW 1/4, Section 24, T 04 S, R 06 W, WM;
1270 FEET NORTH & 410 FEET WEST FROM S1/4 CORNER OF SECTION 24
(point 2) SE 1/4 SW 1/4, Section 24, T 04 S, R 06 W, WM;
1200 FEET NORTH & 290 FEET WEST FROM S1/4 CORNER OF SECTION 24
(point 3) SW 1/4 SE 1/4, Section 24, T 04 S, R 06 W, WM;
670 FEET NORTH & 320 FEET EAST FROM S 1/4 CORNER SECTION 24

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
