CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

ESTON DUMONT
of 8584 LITTLE RIVER RD GLIDE, OR 97443
has a right to the use of the waters of UNNAMED STREAM AND LITTLE RIVER, TRIBUTARY OF NORTH UMPQUA RIVER
for the purpose of DOMESTIC USE FOR ONE FAMILY AND IRRIGATION.

The right to the use of these waters has been perfected under Permit 43746. The date of priority is APRIL 19, 1978. The right is limited to not more than 0.181 CUBIC FOOT PER SECOND; BEING 0.005 CFS FOR DOMESTIC FROM UNNAMED STREAM AND 0.176 CFS FOR IRRIGATION FROM LITTLE RIVER or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

(point 1) LOT 7, SW 1/4 NE 1/4, Section 12, T 27 S, R 03 W, WM;
1460 FEET SOUTH & 2300 FEET WEST FROM NE CORNER, SECTION 12
(point 2) LOT 6, SE 1/4 NW 1/4, Section 12, T 27 S, R 03 W, WM;
2420 FEET SOUTH & 2570 FEET WEST FROM NE CORNER, SECTION 12

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
