THIS IS TO CERTIFY, that

SUNRIVER PROPERTIES, INC (AN OREGON CORPORATION)

has a right to the use of the waters of WELL #2 IN

has a right to the use of the waters of WELL #2 IN THE DESCHUTES RIVER BASIN

for the purpose of GROUP DOMESTIC AND COMMERCIAL USES.

The right to the use of these waters has been perfected under Permit G 3810. The date of priority is SEPTEMBER 5, 1967. The right is limited to not more than 2.3 CUBIC FEET PER SECOND; BEING 1.15 CFS FOR DOMESTIC AND 1.15 CFS FOR COMMERCIAL or its equivalent in case of rotation, measured at the well. The well is located as follows:

SW 1/4 SW 1/4, Section 32, T 19 S, R 11 E, WM; 1070 FEET NORTH & 1300 FEET EAST FROM SW CORNER OF SECTION 32

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
