THIS IS TO CERTIFY, that

SUNRIVER PROPERTIES, INC (AN OREGON CORPORATION)
 of PO BOX 3589 SUNRIVER, OR 97701
 has a right to the use of the waters of SUNRIVER WELL #4 in the
 DESCHUTES RIVER basin for the purpose of GROUP DOMESTIC.

The right has been perfected under Permit G 5609. The
 date of priority is AUGUST 28, 1972. The right is limited to not
 more than 1.100 CUBIC FEET PER SECOND or its equivalent in case
 of rotation, measured at the well. The well is located as follows:

SW 1/4 SE 1/4, Section 6, T 20 S, R 11 E, WM;
 340 FEET NORTH & 1410 FEET WEST FROM SE CORNER OF SECTION 6

The right shall conform to such reasonable rotation system
 as may be ordered by the proper state officer.
