has a right to the use of the waters of CYRUS-KEETON WELL in the SQUAW CREEK basin for the purpose of IRRIGATION.

The right has been perfected under Permit G 6857. The date of priority is FEBRUARY 27, 1976. The right is limited to not more than 3.660 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well. The well is located as follows:

NW 1/4 NW 1/4, Section 13, T 15 S, R 10 E, WM; 180 FEET SOUTH & 60 FEET EAST FROM NW CORNER OF SECTION 13

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
