CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

JOHN WEISZ, JR
of 15005 BUTTEVILLE RD NE GERSAIS, OR 97026
has a right to the use of the waters of TWO WELLS IN THE SENECA
CREEK BASIN
for the purpose of IRRIGATION.

The right to the use of these waters has been perfected
under Permit G 7219. The date of priority is FEBRUARY 24, 1977.
The right is limited to not more than 2.46 CFS, BEING 0.27 CFS FROM
WELL #1, AND 2.19 CFS FROM WELL #2
or its equivalent in case of rotation, measured at the well. The
well is located as follows:

(well # 1) DLC 57, NE 1/4 SW 1/4, Section 14, T 05 S, R 02 W, WM;
1750 FEET NORTH & 3370 FEET EAST FROM SE COR OF LACHAPELLE DLC 41
(well # 2) DLC 57, SE 1/4 SE 1/4, Section 15, T 05 S, R 02 W, WM;
890 FEET NORTH & 20 FEET EAST FROM SE CORNER OF LACHAPELLE DLC 41

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-EIGHTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 2.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
