CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

CEDAR CREEK IRRIGATION ASSOCIATION
of 7606 MCKENZIE HWY SPRINGFIELD, OR 97477
has a right to the use of the waters of MCKENZIE RIVER
a tributary of WILLAMETTE RIVER for the purpose of IRRIGATION.

The right has been perfected under Permit 31974. The
date of priority is SEPTEMBER 2, 1966. The right is limited to not
more than 1.190 CUBIC FEET PER SECOND or its equivalent in case
of rotation, measured at the point of diversion from the source.
The point of diversion is located as follows:

LOT 6, SE 1/4 SW 1/4, Section 29, T 17 S, R 01 W, WM;
220 FEET NORTH & 810 FEET WEST FROM S1/4 CORNER SECTION 29. *

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-EIGHTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 2.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:

REDIVERSION FROM CEDAR CREEK: 1 - 1120 FEET NORTH & 560 FEET EAST FROM C1/4 CORNER SECTION 31, T17S, R1W, WM; 2 - 640 FEET SOUTH & 360 FEET EAST FROM NW CORNER SECTION 31, T17S, R1W, WM; 3 - 170 FEET NORTH & 80 FEET EAST FROM SE CORNER LOT 2, SECTION 36, T17S, R2W, WM; 4 - 340 FEET NORTH & 1010 FEET WEST FROM SE CORNER WHITTAKER DLC 53; 5 - 280 FEET NORTH & 600 FEET EAST FROM NW CORNER DAVIS DLC 50; 6 - 10 FEET NORTH & 650 FEET EAST FROM NW CORNER LOONEY DLC 54; 7 - 490 FEET SOUTH & 150 FEET WEST FROM NW CORNER LOONEY DLC 54.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
