CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

LEE & MARJORIE BATES

of 1725 PEARL ST W TILLAMOOK, OR 97141

has a right to the use of the waters of POWDER RIVER
a tributary of SNAKE RIVER for the purpose of IRRIGATION.

The right has been perfected under Permit 36473. The
date of priority is AUGUST 24, 1971. The right is limited to not
more than 3.600 CUBIC FEET PER SECOND or its equivalent in case
of rotation, measured at the point of diversion from the source.
The point of diversion is located as follows:

SW 1/4 SE 1/4, Section 17, T 08 S, R 42 E, WM;
650 FEET NORTH & 2540 FEET WEST FROM SE CORNER, SECTION 17

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-FORTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 3.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
