CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

ROBERT D. CHASE  
of 11412 HWY. 238 JACKSONVILLE, OR 97530  
has a right to the use of the waters of APPELGATE LAKE RESERVOIR,  
CONSTRUCTED UNDER PERMIT R-7810 TRIBUTARY OF APPELGATE RIVER  
for the purpose of SUPPLEMENTAL IRRIGATION OF 4.4 ACRES.

The right to the use of these waters has been perfected  
under Permit 46023. The date of priority is AUGUST 7, 1981.  
The right is limited to not more than 4.4 ACRE-FEET STORED WATER  
ONLY  
or its equivalent in case of rotation, measured at the point of  
diversion from the source. The point of diversion is located as  
follows:

LOT 10, SE 1/4 SW 1/4, Section 28, T 38 S, R 03 W, WM;  
40 FEET NORTH & 1610 FEET EAST FROM SW CORNER SECTION 28

The right shall conform to such reasonable rotation system  
as may be ordered by the proper state officer.

A description of the place of use under the right, and to  
which such right is appurtenant, is as follows:

Total: 4.40 supplemental acres.

This right is limited to a diversion of 4.5 acre-feet per acre  
for each acre irrigated during the irrigation season of each year,  
provided further that the right allowed herein shall be limited to  
any deficiency in the available supply of any prior right existing  
for the same land and shall not exceed the limitation allowed  
herein, and is subject to the terms and conditions of contract No.  
1-07-10-W0360, or a satisfactory replacement, between the Bureau  
of Reclamation and the applicant, a copy of which is on file in  
the records of the Water Resources Department.

\* Applegate Dam is located in the S1/2 SE1/4, Section 25, T40S, R4W,  
W.M.

The right to the use of the water for the above purpose is  
restricted to beneficial use on the lands or place of use described.  
The right is subject to minimum flows established by the Water  
Resources Commission with an effective date prior to this right.
