CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

PETER W SCHOENINGH JR
of ROUTE 1, BOX 116 HAINES, OR 97833
has a right to the use of the waters of A NATURAL DRAINAGEWAY, A
TRIBUTARY OF POWDER RIVER
for the purpose of SUPPLEMENTAL IRRIGATION.

The right to the use of these waters has been perfected
under Permit 36970. The date of priority is JUNE 5, 1972.
The right is limited to not more than 4.47 CUBIC FEET PER SECOND
or its equivalent in case of rotation, measured at the point of
diversion from the source. The point of diversion is located as
follows:

NW 1/4 SW 1/4, Section 7, T 07 S, R 39 E, WM;
300 FEET SOUTH & 50 FEET EAST FROM W1/4 CORNER, SECTION 7

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-FORTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 3.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year. The
right shall be limited to any deficiency in the available supply of
any prior right for the same land and shall not exceed the
limitation allowed herein.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
