CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

PETE SCHOENINGH
of ROUTE 1 BOX 116 HAINES, OR 97833
has a right to the use of the waters of TWO UNNAMED DRAINAGEWAYS
TRIBUTARY TO POWDER RIVER
for the purpose of SUPPLEMENTAL IRRIGATION.

The right to the use of these waters has been perfected
under Permit 38977. The date of priority is MARCH 1, 1974.
The right is limited to not more than 1.33 CUBIC FEET PER SECOND;
BEING 0.855 CFS FROM POINT 1 AND 0.475 CFS FROM POINT 2
or its equivalent in case of rotation, measured at the point of
diversion from the source. The point of diversion is located as
follows:

- (point 1) NW 1/4 NE 1/4, Section 7, T 07 S, R 39 E, WM;
340 FEET SOUTH & 40 FEET EAST FROM N1/4 CORNER OF SECTION 7
- (point 2) SE 1/4 NW 1/4, Section 7, T 07 S, R 39 E, WM;
1350 FEET SOUTH & 460 FEET WEST FROM N1/4 CORNER OF SECTION 7

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-FORTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 3.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year. The
right shall be limited to any deficiency in the available supply of
any prior right for the same land and shall not exceed the
limitation allowed herein.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:

The right is subject to minimum flows established by the Water
Resources Commission with an effective date prior to this right.
