 CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

J.B. SOD & SEED
 of 5289 BLUE GRASS LANE NE SILVERTON, OR 97381
 has a right to the use of the waters of JANZ WELL in the
 PUDDING RIVER basin for the purpose of IRRIGATION.

The right has been perfected under Permit G 6916. The
 date of priority is JUNE 21, 1976. The right is limited to not
 more than 1.340 CUBIC FEET PER SECOND or its equivalent in case
 of rotation, measured at the well. The well is located as follows:

DLC 40, SE 1/4 SW 1/4, Section 36, T 06 S, R 02 W, WM;
 350 FEET SOUTH & 570 FEET WEST FROM NW CORNER OF SHANNON DLC 38

CANCELED

The amount of water used for irrigation, together with the
 amount secured under any other right existing for the same lands,
 shall be limited to ONE-EIGHTIETH of one cubic foot per second per
 acre, or its equivalent for each acre irrigated and shall be further
 limited to a diversion of not to exceed 2.5 acre-feet per acre for
 each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
 as may be ordered by the proper state officer.

A description of the place of use under the right, and to
 which such right is appurtenant, is as follows:
