CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

JOAN F. COMBS  
JOHN F. BARBIER  
of 1654 PINE GATE WAY WHITE CITY, OR 97503  
has a right to the use of the waters of ROGUE RIVER  
a tributary of PACIFIC OCEAN for the purpose of IRRIGATION.

The right has been perfected under Permit 37599. The date of priority is JANUARY 22, 1973. The right is limited to not more than 0.100 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

- (point 1) LOT 3, NE 1/4 NW 1/4, Section 32, T 35 S, R 01 W, WM;  
170 FEET SOUTH & 1510 FEET EAST FROM NW CORNER, SECTION 32
- (point 2) LOT 3, SW 1/4 NW 1/4, Section 32, T 35 S, R 01 W, WM;  
1440 FEET SOUTH & 270 FEET EAST FROM NW CORNER, SECTION 32

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
