CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

USDA--FARMERS HOME ADMINISTRATION, of 1229 SE 3RD--SUITE A, PENDLETON, OREGON 97801, has a right to the use of A WELL in the COLUMBIA RIVER basin for the purpose of IRRIGATION OF 165.8 ACRES.

The right has been perfected under Permit G 4722. The date of priority is SEPTEMBER 25, 1969. The right is limited to not more than 0.9 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well. The well is located as follows:

SE1/4 NE1/4, SECTION 31, T2N, R24E, WM; 10 FEET NORTH & 10 FEET WEST FROM THE E1/4 CORNER OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

- 18.0 ACRES NE1/4 NW1/4
- 47.6 ACRES NW1/4 NW1/4
- 44.8 ACRES SW1/4 NW1/4
- 14.4 ACRES SE1/4 NW1/4
- 39.5 ACRES NW1/4 SW1/4
- 1.5 ACRES SW1/4 SW1/4
