has a right to the use of the waters of APPLEGATE LAKE RESERVOIR, CONSTRUCTED UNDER PERMIT R-7810, A TRIBUTARY OF APPLEGATE RIVER for the purpose of SUPPLEMENTAL IRRIGATION.

The right to the use of these waters has been perfected under Permit 46389. The date of priority is AUGUST 10, 1981. The right is limited to not more than 66.0 ACRE-FEET STORED WATER ONLY

or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

DLC 38, SW 1/4 NW 1/4, Section 28, T 38 S, R 03 W, WM; 380 FEET NORTH & 510 FEET WEST FROM INTERIOR 'L' COR LACLAIR DLC 38

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
