CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

GREEN VILLA FARMS
of 5605 HALLS FERRY RD INDEPENDENCE, OR 97351
has a right to the use of the waters of HUMBUG LAKE & WILLAMETTE
RIVER, TRIBUTARY OF COLUMBIA RIVER
for the purpose of IRRIGATION.

The right to the use of these waters has been perfected
under Permit 38409. The date of priority is DECEMBER 21, 1973.
The right is limited to not more than 10.2 CUBIC FEET PER SECOND;
WATER TO BE DIVERTED FROM HUMBUG LAKE WHEN AVAILABLE WITH ANY
DEFICIENCY IN THE AVAILABLE SUPPLY FROM HUMBUG LAKE TO BE MADE UP BY
APPROPRIATION FROM WILLAMETTE RIVER PROVIDED THAT THE TOTAL *
or its equivalent in case of rotation, measured at the point of
diversion from the source. The point of diversion is located as
follows:

- (point 1) LOT 9, SW 1/4 SW 1/4, Section 11, T 08 S, R 04 W, WM;
520 FEET NORTH & 50 FEET EAST FROM NW CORNER, SECTION 14
- (point 2) DLC 40, SE 1/4 SE 1/4, Section 10, T 08 S, R 04 W, WM;
30 FEET NORTH & 400 FEET WEST FROM NW CORNER, SECTION 14
- (point 3) DLC 40, SE 1/4 NE 1/4, Section 15, T 08 S, R 04 W, WM;
1460 FEET SOUTH & 470 FEET WEST FROM NW CORNER, SECTION 14
- (point 4) NE 1/4 NW 1/4, Section 14, T 08 S, R 04 W, WM;
460 FEET SOUTH & 2560 FEET EAST FROM NW CORNER, SECTION 14

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-EIGHTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 2.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
