has a right to the use of the waters of SALT CREEK AND ROSS SIMPSON RESERVOIR, CONSTRUCTED UNDER PERMIT R-6057, TRIBUTARY OF SOUTH YAMHILL RIVER

for the purpose of IRRIGATION, FISH CULTURE AND RECREATION.

The right to the use of these waters has been perfected under Permit 37325. The date of priority is SEPTEMBER 5, 1973 The right is limited to not more than 0.90 CUBIC FOOT PER SECOND; BEING 0.80 CFS FOR IRRIGATION AND 0.10 CFS FOR FISH CULTURE AND RECREATION

or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

DLC 47, NE 1/4 NE 1/4, Section 21, T 07 S, R 05 W, WM; 200 FEET SOUTH & 590 FEET WEST FROM NE CORNER, SECTION 21

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
