CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

LESLIE W ORMSBY
C/O MARGARET ORMSBY
of 12320 TAKILMA RD CAVE JUNCTION, OR 97523
has a right to the use of the waters of LONG GULCH AND PEGGY'S POND,
CONSTRUCTED UNDER PERMIT R-4967, TRIBUTARY OF EAST FORK ILLINOIS
RIVER
for the purpose of DOMESTIC USE FOR TWO FAMILIES, IRRIGATION,
FIRE PROTECTION AND FISH CULTURE.

The right to the use of these waters has been perfected
under Permit 32370. The date of priority is OCTOBER 20, 1966.
The right is limited to not more than 0.16 CUBIC FOOT PER SECOND;
BEING 0.01 CFS FOR DOMESTIC; 0.13 CFS FOR IRRIGATION FROM LONG
GULCH; 0.01 CFS FOR MAINTENANCE OF A FIRE PROTECTION SYSTEM; AND
0.01 CFS FOR FISH CULTURE FROM LONG GULCH AND RESERVOIR
or its equivalent in case of rotation, measured at the point of
diversion from the source. The point of diversion is located as
follows:

- (point 1) SW 1/4 SW 1/4, Section 10, T 41 S, R 08 W, WM;
1950 FEET SOUTH & 1400 FEET WEST FROM CENTER, SECTION 10
- (point 2) NW 1/4 SE 1/4, Section 10, T 41 S, R 08 W, WM;
1300 FEET SOUTH & 150 FEET EAST FROM CENTER, SECTION 10

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-FIFTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 3.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
