has a right to the use of the waters of ROUGH & READY CREEK, TRIBUTARY OF ILLINOIS RIVER

for the purpose of SUPPLEMENTAL IRRIGATION.

The right to the use of these waters has been perfected under Permit 38061. The date of priority is FEBRUARY 5, 1974 FOR 0.08 CFS & MAY 9, 1974 FOR 0.79 CFS.

The right is limited to not more than 0.87 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

SW 1/4, Section 14, T 40 S, NE 1/4 R 09 W, WM; 2000 FEET NORTH & 700 FEET WEST FROM S 1/4 CORNER SECTION 14

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system

as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
