CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

LARRY J SCHRENK
 CORRIN M SCHRENK
 of PO BOX 306 CRESWELL, OR 97426
 has a right to the use of the waters of BEAR CREEK AND COAST FORK
 WILLAMETTE RIVER, TRIBUTARY OF WILLAMETTE RIVER
 for the purpose of IRRIGATION.

The right to the use of these waters has been perfected
 under Permit 38199. The date of priority is JUNE 6, 1974.
 The right is limited to not more than 2.43 CUBIC FEET PER SECOND
 FROM BEAR CREEK WHEN AVAILABLE, ANY DEFICIENCY IN THE AVAILABLE
 SUPPLY FROM BEAR CREEK TO BE MADE UP BY APPROPRIATION FROM THE COAST
 FORK WILLAMETTE RIVER PROVIDED THAT THE TOTAL QUANTITY OF WATER *
 or its equivalent in case of rotation, measured at the point of
 diversion from the source. The point of diversion is located as
 follows:

(point 1)DLC 71, NW 1/4 NE 1/4, Section 6, T 19 S, R 02 W, WM;
 1110 FEET NORTH & 700 FEET EAST FROM SW CORNER OF DLC #71
 (point 2)DLC 50, NE 1/4 SW 1/4, Section 6, T 19 S, R 02 W, WM;
 1550 FEET SOUTH & 630 FEET WEST FROM SW CORNER OF DLC #71

The amount of water used for irrigation, together with the
 amount secured under any other right existing for the same lands,
 shall be limited to ONE-EIGHTIETH of one cubic foot per second per
 acre, or its equivalent for each acre irrigated and shall be further
 limited to a diversion of not to exceed 2.5 acre-feet per acre for
 each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
 as may be ordered by the proper state officer.

A description of the place of use under the right, and to
 which such right is appurtenant, is as follows:
