CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

JAMES E & NEDRA JOHAM
of RIVER ROUTE BOX 920 SILETZ, OR 97380
has a right to the use of the waters of AN UNNAMED STREAM AND EUCHRE
CREEK, TRIBUTARIES OF SILITZ RIVER
for the purpose of DOMESTIC USE FOR ONE FAMILY AND IRRIGATION
OF 74.7 ACRES.

The right to the use of these waters has been perfected
under Permit 38255. The date of priority is JUNE 8, 1973.
The right is limited to not more than 0.935 CUBIC FOOT PER SECOND;
BEING 0.005 CFS FROM UNNAMED STREAM FOR DOMESTIC AND 0.93 CFS FOR
IRRIGATION FROM EUCHRE CREEK
or its equivalent in case of rotation, measured at the point of
diversion from the source. The point of diversion is located as
follows:

- (point 1) SE 1/4 NW 1/4, Section 22, T 09 S, R 10 W, WM;
1930 FEET SOUTH & 1440 FEET EAST FROM NW CORNER OF SECTION 22
- (point 2) NE 1/4 SW 1/4, Section 22, T 09 S, R 10 W, WM;
2740 FEET SOUTH & 2140 FEET EAST FROM NW CORNER OF SECTION 22

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-EIGHTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 2.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
