CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

SCOTT M MCCOLLUM
of 1625 N RIVER RD GOLD HILL, OR 97525
has a right to the use of the waters of LOST CREEK RESERVOIR
CONSTRUCTED UNDER PERMIT R-8142, A TRIBUTARY OF ROGUE RIVER
for the purpose of SUPPLEMENTAL IRRIGATION.

The right to the use of these waters has been perfected
under Permit 46071. The date of priority is JULY 31, 1981.
The right is limited to not more than 15.0 ACRE-FEET STORED WATER
ONLY
or its equivalent in case of rotation, measured at the point of
diversion from the source. The point of diversion is located as
follows:

SE 1/4 NE 1/4, Section 24, T 36 S, R 04 W, WM;
290 FEET NORTH & 1270 FEET WEST FROM E1/4 CORNER, SECTION 24 *

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:

* Lost Creek Dam is located in NW1/4 SW1/4, Section 26, T33S,
R1E, W.M.

This right is limited to a diversion of 4.5 acre-feet per acre
for each acre irrigated during the irrigation season of each year,
provided further that the right allowed herein shall be limited to
any deficiency in the available supply of any prior right existing
for the same land and shall not exceed the limitation allowed
herein, and is subject to the terms and conditions of contract No.
1-07-10-W0411 , or a satisfactory replacement, between the Bureau
of Reclamation and the applicant, a copy of which is on file in
the records of the Water Resources Department.

The right to the use of the water for the above purpose is
restricted to beneficial use on the lands or place of use described.
The right is subject to minimum flows established by the Water
Resources Commission with an effective date prior to this right.
