CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that KROUSE RANCH, INC., of 15911 NORTH APPLEGATE ROAD, GRANTS PASS, OREGON 97526, has a right to the use of the waters of APPLEGATE RIVER, a tributary of ROGUE RIVER, for the purpose of IRRIGATING 35.2 ACRES.

The right has been perfected under Permit 27727. The date of priority is NOVEMBER 21, 1961. The right is limited to not more than 0.88 CUBIC FOOT PER SECOND or its equivalent in case of rotation.

The point of diversion is located as follows:

NE1/4 SE1/4, SECTION 7, T38S, R4W, WM; 1310 FEET SOUTH AND 880 FEET WEST FROM E1/4 CORNER, SECTION 7

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, OR ITS EQUIVALENT FOR EACH ACRE IRRIGATED AND SHALL BE FURTHER LIMITED TO A DIVERSION OF NOT TO EXCEED 4 1/2 ACRE-FEET PER ACRE FOR EACH ACRE IRRIGATED DURING THE IRRIGATION SEASON OF EACH YEAR, PROVIDED FURTHER THAT THE RIGHT TO THE USE OF WATER IS LIMITED TO THE PERIOD WHEN THE FLOW OF THE ROGUE RIVER IS MORE THAN 735 CFS AT ITS MOUTH.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW1/4 NE1/4 13.8 ACRES SE1/4 NE1/4 4.2 ACRES NE1/4 SE1/4 8.2 ACRES NW1/4 SE1/4 2.0 ACRES SECTION 7

SW1/4 NW1/4 7.0 ACRES
SECTION 8
TOWNSHIP 38 SOUTH, RANGE 4 WEST, WM

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered APRIL 7, 1976, and supersedes certificate 35462, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
