CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that DAVID R. KLUGE, of 23550 SW LOGANBERRY LANE, SHERIDAN, OREGON 97378, has a right to the use of the waters of SOUTH YAMHILL RIVER, a tributary of YAMHILL RIVER, for the purpose of IRRIGATING 23.5 ACRES.

The right has been perfected under Permit 34700. The date of priority is SEPTEMBER 25, 1969. The right is limited to not more than 0.25 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 1 (NW1/4 SW1/4), LOT 2(NW1/4 SW1/4) Section 31, T5S, R5W, WM; 100 feet WEST AND 50 FEET EAST from NE Corner, DLC 75

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
