of P.O. BOX 502, MILTON-FREEWATER, OR 97862 has a right to the use of the waters of DUGGER CREEK, A TRIBUTARY OF PINE CREEK

for the purpose of IRRIGATION OF 118.5 ACRES, DOMESTIC AND STOCK USE.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is recorded at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, page 321. The date of priority is 1890 FOR 17.7 ACRES, 1894 FOR 12.0 ACRES, 1908 FOR 19.0 ACRES AND 1900 FOR 69.8 ACRES.

The right is limited to an amount of water actually beneficially used for said purposes, and shall not exceed A RATE OF FLOW OF 1.49 SECOND FEET FROM MAY 1 TO SEPTEMBER 1 OF EACH YEAR, THE TOTAL QUANTITY DIVERTED DURING EACH IRRIGATION SEASON NOT TO EXCEED 355.5 ACRE-FEET.
