CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

CITY OF PRINEVILLE

of 400 EAST 3RD PRINEVILLE, OR 97754

has a right to the use of the waters of STEARNS WELL #2 in the OCHOCO CREEK basin for the purpose of MUNICIPAL USES.

The right has been perfected under Permit G 9154. The date of priority is OCTOBER 5, 1973. The right is limited to not more than 1.560 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well. The well is located as follows:

SW 1/4 NE 1/4, Section 4, T 15 S, R 16 E, WM; 1810.2 FEET SOUTH & 1151.5 FEET EAST FROM N1/4 CORNER OF SECTION 4

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
