has a right to the use of the waters of LOSTINE RIVER AND SPRING, TRIBUTARY OF WALLOWA RIVER

for the purpose of IRRIGATION OF 58.7 ACRES AND DOMESTIC USE FOR ONE FAMILY.

The right to the use of these waters has been perfected under Permit 39272. The date of priority is JULY 3, 1974. The right is limited to not more than 1.475 CUBIC FEET PER SECOND, BEING 1.47 CFS FROM RIVER FOR IRRIGATION AND 0.005 CFS FROM SPRING FOR DOMESTIC

or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

(point 1) NW 1/4 SE 1/4, Section 27, T 01 S, R 43 E, WM; 2870 FEET SOUTH & 220 FEET EAST FROM N1/4 CORNER, SECTION 27 (point 2) NW 1/4 NW 1/4, Section 8, T 01 S, R 43 E, WM; 1270 FEET SOUTH & 2140 FEET WEST FROM N1/4 CORNER, SECTION 8

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
