CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That SARAH P. GLENN

of Oak Grove State of Oregon has a right to the use of the waters of Camp and Pine Creeks, tributary to Crooked River, and Crooked River

for the purpose of the irrigation of 318 acres of land and stock and domestic use,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 1, at page 449; that the priority of the right hereby confirmed dates from the year 1888 for the irrigation of Tract No. 1, with the waters of Camp and Pine Creeks; and from 1891 for the irrigation of Tract No. 2, with the waters of Crooked River,

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a reasonable amount for stock and domestic use, and 3.98 cubic feet per second from July 1st to September 15th of each year for irrigation. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

35 acres in Tract No. 1, located as follows: 10 acres in the NE 1/4 of NW 1/4; 10 acres in the NW 1/4 of NW 1/4; 5 acres in the SW 1/4 of NW 1/4; of Section Six (6), Township Eighteen (18) South Range Twenty-two (22) East of Willamette Meridian; 10 acres in the NE 1/4 of NE 1/4; Section One (1), Township Eighteen (18) South Range Twenty-one (21) East of Willamette Meridian, in Crook County, Oregon.

283 acres in Tract No. 2, located as follows: 37 acres in the NW 1/4 of NE 1/4; 27 acres in the NE 1/4 of NE 1/4; 38 acres in the NW 1/4 of NW 1/4; 25 acres in the NE 1/4 of NW 1/4; Section Twelve (12), Township Seventeen (17) South Range Twenty-one (21) East of Willamette Meridian; 40 acres in the SW 1/4 of SE 1/4; 20 acres in the SE 1/4 of SE 1/4; 20 acres in the SW 1/4 of SW 1/4; 40 acres in the SE 1/4 of SW 1/4; Section Six (6); 6 acres in the SW 1/4 of NW 1/4; 20 acres in the SE 1/4 of NW 1/4; Section Eight (8), Township Seventeen (17) South Range Twenty-two (22) East of Willamette Meridian, in Crook County, Oregon.

The limited irrigation season will conform to the season as defined in the Decree. See document filed adjacent to Certificate 575

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
