CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

DAVID P CALAHAN  
JANICE J CALAHAN &/OR SURVIVORS  
of 11000 HWY 238 JACKSONVILLE, OR 97530  
has a right to the use of the waters of CALAHAN SPRINGS #2, #3 & #4,  
TRIBUTARY OF LONG GULCH  
for the purpose of SUPPLEMENTAL DOMESTIC USE FOR ONE FAMILY  
INCLUDING THE IRRIGATION OF LAWN AND GARDEN NOT TO EXCEED 1/2  
ACRE IN AREA.

The right to the use of these waters has been perfected  
under Permit 42587. The date of priority is OCTOBER 17, 1977.  
The right is limited to not more than 4 GALLONS PER MINUTE, BEING 2  
GPM FROM SPRING #2, AND 1 GPM EACH FROM SPRING #3 AND #4.  
or its equivalent in case of rotation, measured at the point of  
diversion from the source. The point of diversion is located as  
follows:

- (point 1) NW 1/4 NE 1/4, Section 19, T 38 S, R 03 W, WM;  
1835 FEET NORTH & 90 FEET EAST FROM CENTER 1/4 CORNER, SECTION 19
- (point 2) NE 1/4 NW 1/4, Section 19, T 38 S, R 03 W, WM;  
1640 FEET NORTH & 10 FEET WEST FROM CENTER 1/4 CORNER, SECTION 19
- (point 3) NW 1/4 SW 1/4, Section 19, T 38 S, R 03 W, WM;  
540 FEET SOUTH & 1680 FEET WEST FROM CENTER 1/4 CORNER, SECTION 19

The right shall conform to such reasonable rotation system  
as may be ordered by the proper state officer.

A description of the place of use under the right, and to  
which such right is appurtenant, is as follows:

	1/4 1/4	SECTION TOWNSHIP RANGE, WM
DOMESTIC	SW SE	19 38 S 03 W

The right to the use of the water for the above purpose is  
restricted to beneficial use on the lands or place of use described.  
The right is subject to minimum flows established by the Water  
Resources Commission with an effective date prior to this right.
