CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

DONALD F SAALFELD
of 385 7TH ST GERVAIS, OR 97026
has a right to the use of the waters of WILLAMETTE RIVER
a tributary of COLUMBIA RIVER for the purpose of IRRIGATION.

The right has been perfected under Permit 41648. The
date of priority is MARCH 28, 1977. The right is limited to not
more than 0.890 CUBIC FOOT PER SECOND or its equivalent in case
of rotation, measured at the point of diversion from the source.
The point of diversion is located as follows:

DLC 73, SE 1/4 NE 1/4, Section 14, T 05 S, R 03 W, WM;
240 FEET NORTH & 660 FEET WEST FROM THE E1/4 CORNER OF SECTION 14

The amount of water used for irrigation, together with the
amount secured under any other right existing for the same lands,
shall be limited to ONE-EIGHTIETH of one cubic foot per second per
acre, or its equivalent for each acre irrigated and shall be further
limited to a diversion of not to exceed 2.5 acre-feet per acre for
each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:
